Welcome to Pawtucket

Just minutes off Interstate 95, Pawtucket's government, business and tourism centers are conveniently situated where the Blackstone River runs into the tumbling Pawtucket Falls. In the new millennium, Pawtucket, like the falls is a *City of Creativity*.

Major revitalization projects have cleaned up the river, provided new docks and office buildings. Indeed, the City has reclaimed its heritage as "the place by the waterfall". This heritage of 72,172 Pawtucket residents is a distinguished place in American History as one of the most important textile manufacturing centers of the 19th century.

In 1793, Samuel Slater constructed and operated the first cotton spinning machine in America at the Slater Mill site by harnessing both the Blackstone River and the waterfall's power. Thus, Slater's Arkwright Spinning Mill helped generate the nation's industrial revolution.

Throughout the 19th and most of the 20th century, Pawtucket was a key force in textiles as well as other manufacturing. Today, a number of specialty textile companies still produce delicate laces, non-woven and elastic woven materials in Pawtucket.

Furthermore, both nationally and internationally renowned companies house their operations in Pawtucket: Hasbro Inc., a worldwide leader in children's and family entertainment, Collette Tours, the world's largest tour package company, and Morris Nathanson Design, the award winning hotel/restaurant designer.

These corporations, along with 300 diversified industries; over 1,000 commercial enterprises and a thriving Arts community have all chosen to locate in Pawtucket because of its business-friendly environment.
