- Q1:** *Per statement on Section 11 Bid Form – Page 11 of 15, a bidder is looking for clarification on the following statement and who does the Letter of Intent originate from: "HAS ENCLOSED HEREWITIH THE REQUIRED BID SECURITY AND A PROPERLY EXECUTED LETTER OF INTENT, WHICH REQUIRES THE UNDERSIGNED TO EXECUTE THE BOND PRIOR TO THE START OF ANY WORK".*
- A1:** *The contractor shall supply a Letter of Intent for the Performance and Payment Bond that originates from the bonding agency.*
- Q2:** *Will the contractor be removing the electric service?*
- A2:** *No. The electric service has been disconnected by the utility company. A new page shall be inserted into the bid form (page 5 of 15 of Section 11 Bid Form) showing this work is removed from the contract and will contain a \$0 amount. Please replace this page of the bid form with the page supplied in this Addendum.*
